### Item 3

# **Program and Certificate (Exit Point) Changes**

Bridgerland Technical College received initial accreditation in 2005. Prior to that time, program design included embedded exit points (similar to Occupational Completion Points in Florida). This design was initially submitted to the Council on Occupational Education (COE) and subsequently approved with the highest level credential approved as the program length. Program level changes were provided as required to COE annually.

In 2017, as a result of Department of Education direction, pages 8-9 of the *Policies Rules of the Commission* manual provided direction and clarification to *Exit Points*.

Bridgerland wishes to comply with the new direction provided by the Commission and ultimately the US Department of Education by eliminating all exit points so program offerings can be advertised in marketing materials. The College wishes to convert popular exit points into stand-alone programs and make clock-hour changes to programs where Advisory Committee input and student demand dictate.

Once approved by the BTECH Board of Directors, application will be forwarded to COE with an effective implementation date of November 1, 2017.

Chad Campbell reviewed the following program changes, which are also detailed on the attached spreadsheet. Board members engaged in a question and answer session. They were pleased to know that Advisory Committee input is important in this decision making process.

# **Report on Governor's Education Summit**

The Governor's Education Summit was held October 13, 2017, at UVU. At this event, Governor Gary Herbert declared 2018 the "Year of Technical Education" in the state of Utah. Statewide Vision, Student Perspectives, Industry Engagement, and Education Delivery were among the panels presented with experts discussing related topics. Bridgerland's Automated Manufacturing & Robotics graduate, John Robinson, represented the College on the 'Student Perspectives' panel as an excellent example of stackable credentials. He is continuing his education at Utah State University in Technology Systems.

As a result of the Governor's Education Summit, Jeff Packer requested a white paper or talking sheet on technical education as a resource for Board Members to use while talking to friends and neighbors. Troy drafted a talking sheet and provided it as a link on the web site. He reviewed the sheet and asked for input. Suggestions can be submitted to Emily Hobbs. Board members engaged in discussion regarding technical education and pondered on how to better inform potential students, parents, and counselors.
