On April 13, 2020, the College signed and returned to the Department the Certification and Agreement as required for the CARES Act. The additional funding from the ARP was based on this original certification. The College intends to use all of the funds for Emergency Financial Aid Grants to students.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the ARP (a)(1) and (a)(4).

The College determined funds would be allocated to the largest number of students possible due to impacts of COVID-19 related events. In order to prioritize those with exceptional need, the College sent out a survey to students. Questions were aimed at determining need such as if students were receiving financial aid from Pell Grant funds or state assistance programs. Other questions asked if students had recently faced loss of employment (for themselves or those supporting them), reduced income, food insecurity, housing insecurity, extraordinary financial circumstances, and/or serious health issues.

The College used the submitted surveys to create a matrix for awards. Applicants received an amount of \$0-\$2,000 based on no need, low need, moderate need, high need, or critical need. Students were given the opportunity to provide written authorization within the survey to apply funds directly to their student account. Those students who did not provide authorization received a check sent directly to the address on file.
