### Higher Education Emergency Relief Fund Reporting - Emergency Financial Aid Grants to Students

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

On April 13, 2020, the College signed and returned to the Department the Certification and Agreement as required. The College intends to follow the stipulations to use no less than 50 percent for Emergency Financial Aid Grants to students.

The College determined funds would be allocated to the largest number of students possible due to impacts of COVID-19 related events. Following Secretary of Education DeVos's guidance, Pell eligible students received priority funding. Disbursed emergency grant funds were released to students by check. Payment was not a reflection of a student's current student account balance, as these funds are disbursed directly to a student no matter if a current balance is owed to the institution.

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Initially, students who had not applied for 2019 or 2020 FAFSA were sent an email informing them of the following:

You may be aware that the government has passed the CARES Act under which federal dollars are available to assist students in meeting expenses related to educational disruptions as a result of the COVID-19 pandemic. You may be eligible for these Higher Education Emergency Relief Funds (HEERF).

Regulation requires HEERF recipients to be eligible for Title IV aid. Bridgerland Technical College will determine student eligibility using the results of the 2019-2020 Free Application for Federal Student Aid (FAFSA). If you are interested in being considered for these funds, submit your 2019-2020 FAFSA online at [fafsa.gov](https://fafsa.gov). Be sure to include Bridgerland's school code on the FAFSA so we will receive your results: 014257.
