



Programs Approved for Veterans Education Benefits

The Utah State Approving Agency for Veterans Education approves the education and training of veterans and other eligible persons at Bridgerland Technical College for various certificate programs. Eligible programs may be considered and approved by the Utah State Department of Veterans Affairs if it provides a required number of hours, is offered during a required number of weeks, leads to a certificate or degree, and prepares students for gainful employment in a recognized occupation.

Note: Not all programs at an eligible institution qualify as eligible programs. Students with a Certificate Seeking enrollment objective may qualify. Students whose enrollment objective is Personal Interest, Online, Job Upgrade, or Short-term do not qualify.

Students enrolled in the following certificate programs may be eligible to receive veteran benefits for the hours indicated () by selecting one of the approved certificates listed. Students may only enroll in and receive benefits for programs identified:
