# OVERVIEW OF GUIDELINES FOR BRIDGERLAND TECHNICAL COLLEGE

## **Focusing On Saving Lives and Livelihoods**

Derived from State of Utah Phased Guidelines for the General Public and Businesses and Bear River Health Department Guidelines

## \*\* ALL SYMPTOMATIC EMPLOYEES, STUDENTS, AND GUESTS SHOULD STAY OFF CAMPUS \*\*

#### **HIGH RISK**

- Campus closure(s) as directed by the state of Utah and/or Bear River Health Department with limited access approved by the President.
- Students, faculty, and employees engage in virtual-only activities and classes (where applicable).
- Group sizes reduced to maximum of 10 persons utilizing social distancing guidelines.
- Eliminate unnecessary travel; utilize virtual meetings, conferences, workshops, and training sessions.
- No third-party events.
- Campus services suspended (i.e., Cafe, program services, HelpDesk, weight/cardio rooms, etc.)
- Increased cleaning/hygiene regimen.

#### **MODERATE RISK**

- Virtual classes and activities continue (where possible).
- Limited scheduled on-campus activities.
- Group sizes reduced to maximum of 20 persons utilizing social distancing guidelines.
- Symptom screening, social distancing, and universal health precautions utilized.
- Documented access for incident monitoring and contact tracing.
- High traffic floor markings.
- Remote work accommodations continue for high-risk employees (where possible).
- Eliminate unnecessary travel.
- Signage throughout buildings promoting social distancing and universal health precautions.
- Increased cleaning/hygiene regimen.
- Face coverings encouraged.
- Drinking fountains and food services remain closed.
- Bookstore purchases mailed and/or curbside pickup.
- No third-party events.

#### **LOW RISK**

- On-campus activities and classes limited to small groups (i.e., 50). Varied access schedules may be required.
- Symptom screening, social distancing, and universal health precautions utilized.
- Document access for incident monitoring and contact tracing.
- Remote work accommodations provided to high-risk employees where possible.
- I imit travel.
- Face coverings encouraged.
- Signage throughout buildings promoting social distancing and universal health precautions.
- Stagger customer serving and seating protocols consistent with restaurant guidance.
- Drinking fountains open with increased sanitation
- Package food in containers that do not need to be returned.
- Increased cleaning/hygiene regimen.
- Campus services resume following current health and safety precautions.
- No third-party events.

### "NEW" NORMAL

- On-campus activities operate within regular safety guidelines.
- Maintain normal room and building capacities.
- Travel restrictions lifted; avoid areas of high transmission.
- Increased cleaning/hygiene regimen.
- Campus services resume.
- Third-party events considered.
- Incident monitoring and contact tracing.

# Students/Faculty can return following illness once one of the following criteria is met:

- 72 hours after all symptoms resolve AND 10 days from when symptoms began
- Proof of a negative COVID test
- 72 hours after resolution of symptoms with an health provider note of an alternative diagnosis (i.e., strep throat)
